MEDICAL AND PARENTAL CONSENT AND RELEASE			
<p>MEDICAL CONSENT: As the legal guardian, if the participant is a minor under the age of 18, I hereby attest that I have read this complete document; all information provided is complete and true. I have legal standing to make decisions which affect the rights of the above-named participant; and, I understand and consent to all terms outlined in this document. I hereby voluntarily and knowingly assume all risks and dangers inherent and incidental to ministry activities and travel, understanding that some activities may pose a risk of injury. I will not hold liable Trinity on the Hill UMC, Augusta, its employees, agents and event/group leaders for any injury, illness or property damage involving the above-named participant, no matter how caused. Whenever deemed necessary by group leaders, I authorize the calling of a doctor and/or the providing of other medical services and, unless covered by insurance, agree to pay for same. If the above-named participant is incapacitated or under age 18, I do hereby authorize group leaders as agent for the undersigned, to consent with respect to such participant to any x-ray, examination, anesthetic, medical, dental or surgical diagnosis and/or treatment, and hospital care which is deemed advisable by a state-licensed physician or surgeon.</p>			
<p>PARENTAL CONSENT (for minor under age 18): As legal guardian of the above-named minor under the age of 18, I give my permission for him/her to be involved in the ministry program(s) of Trinity on the Hill UMC, Augusta. I am familiar with the general goals and purposes of the program(s). This information will not be publicly disseminated or released to outside organizations. However, since it is common practice for the Church to publish a participant's address, phone number and/or birthday on the group's roster, if they actively participate in the group, I authorize the Church to publish such information on a local (or event) roster.</p>			
<p>LIMIT OF CONSENT: The consent outlined in this Children's/Youth Activity Authorization & Medical/Liability Release, concerning my child's participation in ministry activities, expires one (1) year from the date signed. It is my responsibility to notify the Church staff or group leaders if any information changes or I decide to withhold consent.</p>

This COVID-19 Parental Consent Form supplements the Authorization & Medical/Liability Release form signed annually by the parents/guardians of participants in Children's and Youth Ministry activities and events. Trinity on the Hill UMC ("Trinity" or "Church") is monitoring the information provided by public health officials and government agencies about how to conduct children's and youth activities in the midst of a pandemic and agrees to follow their guidelines and recommendations. These efforts cannot completely eliminate the potential for exposure to COVID-19. Each family must evaluate their unique circumstances, including any underlying medical conditions which may increase risk for severe illness from COVID-19, and make informed decisions before participating in Trinity's children's and youth activities and events.

Covenant:

- I will not send my child/youth to an activity/event if he/she has a temperature of 100.4 degrees F or higher or exhibits symptoms of cough, shortness of breath, chills, headache, or sore throat.
- If my child/youth is exposed to someone who tests positive for COVID-19 or someone who is exhibiting symptoms of COVID-19, I will not send them to a Trinity activity/event for a period of 14 days.
- If my child/youth tests positive for COVID-19, I will notify the Minister/Director and not allow them to participate in Trinity activities/events until they are symptom free for 72 hours without medication AND 10 days after symptoms first appeared.
- I will ensure that my child/youth abides by any COVID-19 protocols required to attend Trinity activities/events.
- On behalf of my participating child, any other parent or guardian for my child, and myself, I hereby release, waive, discharge, covenant not to sue, and agree to hold harmless for any and all purposes the Church and its directors, officers, employees, volunteers, agents, donors, related parties, or other organizations ("Releasees") associated with any Church-sponsored activity or event, from any and all liabilities, claims, demands, or injuries, including death, that may be sustained by my child because of his/her participation in Church-sponsored activities or events. Without in any way limiting the foregoing, I expressly acknowledge that my release, waiver, discharge, covenant not to sue, and agreement to hold harmless includes negligence, as well as any and all claims whatsoever arising from or related to COVID-19. This agreement does not release or hold harmless Releasees from claims arising from their intentional misconduct or gross negligence.
